Family Members

Family Membership consists of a household of Members which may include a spouse or partner and/or their children. Children shall be included in Family Membership until they are 18 years.

Parent/s and/or extended family residing with a couple will have to pay separate membership fees unless they qualify for 65+ membership (refer below).

Single Member

Single Membership consists of a Member who seeks sole membership to CDIA, regardless of whether they are with or without a spouse or partner and/or children. The benefits of CDIA single membership shall extend to that Member only, and shall not extend to their spouse or partner and/or their children.

65+ Membership

A CDIA member shall be exempted from paying the annual CDIA subscription once that member has:

- (i) reached the age of 65 as of 1st January of the financial year and
- (ii) has been a financial member for a period of 10 or more consecutive years prior to

1st January of the financial year.

For a couple when only one spouse or partner qualifies this exemption of the annual CDIA subscriptions will also apply to the non-qualified spouse or partner.

Exemption of the annual CDIA subscription does not extend towards the payment of any entry fees and/or costs payable for events hosted by CDIA.

cdia functions for 2020

With the current COVID -19 restrictions our Committee will re-look at whether CDIA hosts any events this year. The functions we host are Janmastami, Ganesh Chaturthi, Navratri, Jalaram Jayanti, Navratri and this year we were planning to host CDIA 75th Jubilee Celebrations is September. NZ currently is at Alert Level 2 and we still do not know how long NZ will remain at Alert Level 2.

Controlling numbers at functions is not easy and we know from past experience we would never know how many people will attend each function, however we do know that at Navratri the numbers are excessive and to implement social distancing at these functions is impossible. Our functions have always been for the wider community and we would like to maintain that and not divide the attendance. We are not aware how members with health issues will feel about gatherings in the current circumstances. As you can see a lot is unknown at the moment and we don't have answers. We do not want to jeopardise all the hard work that New Zealanders have done to date in the fight against COVID-19.

For the safety of our community and CDIA members our committee needs to be vigilant and be aware that the likely decision CDIA Committee will take is to cancel our events for 2020.

With regards to Diwali 2020, PNCC had plans to host this in the square again this year, however with COVID-19 no meetings have been held to date. We will wait for PNCC's announcement on this matter.
