### business owners close, to show solidarity

Dairy owners, liquor store owners and small supermarket owners decided to close their businesses on 27<sup>th</sup> November at 3:00pm onwards to show solidarity towards the sad loss of Janakbhai Patel of Sandringham, Auckland.

Business owners, workers, members and some public gathered in the rain in Te Marae o Hine/The Square to pay their respects to Janakbhai Patel just prior to his funeral service which was carried out at 5:00pm in Auckland.

Many of those that attended had placards making a strong statement that **ENOUGH IS ENOUGH** message to both local and central government. The gathering included candles been lit, a photo of Janakbhai been placed along with some flowers and a Diya was lit. Ladies sang and then a minutes silence was held prior to speeches. Myself, His Worship the Mayor Grant Smith, Deputy Mayor Debbie Marshall-Lobb, Vijaybhai Patel of Awapuni 4 Square, Jaye-shbhai Patel of Rangiora Mini Supermarket and Chirag Ganid, all spoke on the need that government needs to step in where more engagement and recommendations are addressed by the government.



The following day Monday 28<sup>th</sup> November again about some business owners met outside the Palmerston North MP Tangi Utikere's office and made speeches which was aligned with the national organised meetings outside other Labour MP offices throughout New Zealand where business owners were asked to close their businesses between 12:30pm to 2:30pm.

Speeches were made by me where I suggested that we need to meet with the Mayor Grant Smith to discuss a wide range of issues facing our business owners within our district. I mentioned that fog cannons may not be the only answer and the idea of bollards was not always shown with enthusiasm with various Councils around New Zealand. Speeches were also given by Manoj Ranchhod of 4 Square Cloverlea, Mahendra Patel of Kaimanawa Store, Jayesh Patel of Rangiora Mini Supermarket and Sanjeeva Singamsetty of Cook Street Mini Mart where many had the same concerns.

## business owners solidarity - cont'd



I organised a lunchtime meeting with the Mayor, Grant Smith on Thursday 8th December where business owners were all asked to attend and for me to take the lead role representing the concerns of the business owners.

Although the meeting was for an hour with finger food lunch provided there were many aspects of discussions raised from fog canons, street security surveillance cameras, in-situ concrete planter boxes, drivers parking on footpaths out side some dairies, neighbourhood patrol, city council staff to be more vigilant, the stupidity of having a free handle inside a business at all times even once the business stops trading for the day which is then safe for any would-be burglars to get out safely once they have broken in which leads onto those business owners that apply through the right channels to have security grilles fitted behind these fire exit doors do not get the answer they require. This obviously leads to some business owners carrying work without correct notification. The time in which obtaining information from Palmerston North City Council building consent authorities is also a main bug bear for the business owners.

Other business owners went further into some of the details and Grant did note all the points that were raised and he gave as answers to some of the points raised however he would be looking into these and see if our concerns could be looked into.

The meeting was well worth it with representatives from over 18 businesses and Grant did state that he wishes to get this group together early in the new year to see where our concerns are at. Thanks, was given to Grant for making time and for the first time listening to our concerns and we thanked him for the lunch.

I feel that these types of measures what has been carried out within Central Districts over the years is something that all associations should be doing within their own areas, especially engaging with and working alongside local councils.
